Information Collection And Use

Log Data

Like many app operators, we collect information that your app sends whenever you visit our app ("Log Data").

This Log Data may include information such as your device's Internet Protocol ("IP") address, Location, the pages of our app that you visit, the time and date of your visit, the time spent on those pages and other statistics.

The Log Data section is for businesses that use analytics or tracking services in websites or apps, like Google Analytics.

About location Data

Location data (User): SSG collects this data when the Automation app is running in the foreground (app open and on-screen) or background (app open but not on-screen) of their mobile device.

We collect exact or approximate location data from User, SSG collects this data from the time of visit market. Location is collected, any time the app is running in the foreground of their mobile device. We use this data to enhance facilities of order and increase sales area. we do not user your data any others area.

Communications

We may use your Personal Information to contact you with newsletters, marketing or promotional materials.

Cookies
